GENERAL INFORMATION

Arrival and Departure

Sites are available from 12pm and accommodation is available from 2pm. Check-out time is 10am.

Office Hours

Office hours are 9:00am-5pm, 7 days a week.

Outdoor Pool

The heated outdoor pool is open 9:00am-6pm daily. Day visitors are not permitted to use the pool/spa. Children under 5 must be constantly supervised and remain in arms reach of a parent/guardian at all times. If your child is in the water that parent/guardian must be in the water too. Children under 12 must be actively supervised and remain in clear view of parent/guardian at all times.

Mini Golf Hire

Available at reception for a \$10 deposit which is returnable once clubs have been returned to office

Jumping Pillow

Maximum people at any one time on the pillow is 30. Children under 12 must be supervised by a parent and/or guardian at all times Children over the age of 14 are not permitted on the Jumping Pillow.

Book Exchange

Available from reception.

Camp Kitchens

Open daily from 8am-10pm.

Bathrooms

We have a family/disabled bathroom and an infant's change room located at toilet blocks 4 and 6 (closed 1 May–31 August). Water is a valuable resource - please use showers sensibly.

Laundries

Coin operated washing machines and dryers are available from 8am – 9pm. Please report any faults to reception.

Individual washing machines and temporary clothes lines are not permitted.

Boom Gates

Upon arrival and payment a pin number for the boom gate will be given to the site holder. Pin numbers will not be issued to any other person. Tailgating at boom gates is prohibited.

Private Property

Management does not accept liability for loss or damage to any caravan, vehicle, tent or lost property in the park. Please make sure you secure all valuables.

Cleanlines

Please ensure that campsites and accommodation are left clean and tidy on departure. Including removing all rubbish from cabins and sites. Cleaning charges may apply if sites/cabins are left in an unreasonable condition.

Recycling

Please separate rubbish and recycling by placing all recyclables in yellow bins and all other general rubbish in the green bins. Please note that Anglesea is plastic bag free at all shops.

Security

Security personnel are on duty during peak times. On site managers are available after hours on 0427 948 635. Visitors must report to reception on arrival and must vacate the park by 10pm

Refunds Refunds will not be issued to guests leaving prior to their nominated departure date.


RULES AND REGULATIONS

- Day visitors are welcome, however they need to register at the ofice.
- A speed limit of 5kph (walking pace) must be observed at all times by all vehicles, bikes, skateboards, and scooters etc.
- Excessive noise, unruly behaviour, vandalism, bad language, unreasonable disturbance or any other conduct which disturbs the peaceful and quiet enjoyment of any site will not be tolerated. Park quiet time is 10 pm to 7 am.
- · Adult supervision is required for children in the park.
- Children and infants under the age of 7 must be accompanied by an adult while in the amenity block.
- A maximum of one caravan, one car, and six guests (exc. infants and no more than four adults) are permitted per site.
- All equipment and belongings, including caravan, tent and vehicles must be contained within site boundaries.
- Awnings, shade sails and garden furniture must be securely fastened when erected and not tied to trees. Trenching around tents and annexes is not permitted.
- Bikes and skateboards are not permitted in the 'bike free zone', must remain on roadways, and are not to be ridden after dusk.
 Helmets must be worn. Razor bikes, pedal racer cars, motorised scooters and e-scooters are not permitted
- All sporting activities are to be played on the recreational area, not on the campsites or road.
- · Dogs are not permitted outside designated dog friendly area.
- Sleeping in any motor vehicle (with the exception of a properly equipped campervan) is not permitted.
- BBQs or heaters that require heat beads or any other type of outdoor heating are not permitted.

IMPORTANT SAFETY PROCEDURES

- First Aid and AED available at Reception
- All vans must have fire extinguishers, fire blanket and working smoke detector.
- A space of two metres between neighbouring camp sites is required for CFA access and to avoid the spread of fire.
- · All drawbars must face the nearest park road for CFA access.
- Open fires are not permitted at any time this includes ALL solid fuel fires including charcoal.
- Please familiarise yourself with the park evacuation plan, which can be found throughout the park in all facilities.
- Evacuation Assembly Points are marked on the park map. Please select an area to meet so that you can account for your friends/ family.
- Once in the assembly area do not return to your vehicle or camp until authorised to do so by emergency services staff.
- In case of emergency do not attempt to move your vehicle, caravan or tent.
- All guests must comply with any total fire ban restrictions and follow advice
- The park BBQs are electric and can be used, however portable gas BBQs and stoves are not permitted on days of total fire ban.
